

OTHER PERMITS, INSPECTIONS, AND OTHER FEES

(Fees are effective April 1, 2009 through March 31, 2010)

In regard to any of the following itemized requests, should the City Council, the City Planning Commission or the Zoning Board of Appeals deem it appropriate to require the use of a court reporter, attorney, engineer, planning consultant, or any other professional service, the applicant shall be required to pay for the actual expense, plus 5% administrative costs, in addition to said filing fee.

| 7a | Reinspection Fees. A fee of \$41.75 per hour shall be charged. A reinspection fee may be assessed for each inspection or reinspection when such portion of work for which inspection is called is not complete or when required corrections are not made. | \$41.75 |
| 7b | This subsection is not to be interpreted as requiring reinspection fees the first time a job is rejected for failure to comply with the requirements of this code, but to regulate the situation when inspections are requested before the job is ready for such inspections. | |
| 7c | Reinspection fees may be assessed when the permit card is not properly posted on the work site, the approved plans are not readily available to the inspector, for failure to provide access on the date for which an inspection is requested, or for deviating from plans requiring the approval of the Building Official. | |
| 7d | To obtain a reinspection, the applicant shall file a request in writing and pay the reinspection fee required. | |
| 7e | In instances where reinspection fees have been assessed, no additional inspection of the work will be performed until the required fees have been paid. | |
